

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

1 (one) Post-Doctoral Research Fellowship

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution Einstein, Eddington and the Eclipse. A global history of the total solar eclipse of 1919 (E3GLOBAL)/Centro Interuniversitário de História das Ciências e Tecnologia, PTDC/FER-HFC/3491/2021, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme PTDC Programme All Scientific Domains, under the following conditions:

1. **Scientific Area:** History of Science and Technology
2. **Requirements for admission:** Hold a PhD degree preferably in History and Philosophy of Science, received during the three years before the submission date, from a host institution distinct from the Center for the History of Science and Technology (CIUHCT).
3. **Additional optional skills and qualifications:** Proficiency in Portuguese, English and German
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas.
5. **Work plan:** Temporary Working title “An eclipse on paper”. The project will survey and analyse newspapers’ coverage around the world of the 1919 total solar eclipse which “proved Einstein right”, most especially in Portugal, Brazil, UK, USA, and Germany. Ability to build a database of news collected, and to construct and maintain the E3GLOBAL project’s website
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](https://www.fciencias.id/regulamento-de-bolsas-de-investigacao-cientifica-da-fciencias.id)).
7. **Place of work:** The work will be developed at the Centro Interuniversitário de História das Ciências e Tecnologia, Faculdade de Ciências da Universidade de Lisboa under the scientific supervision of Professor Ana Simões.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in March 2022. The fellowship contract may be potentially renewed for 24 months.
9. **Monthly allowance:** The fellowship amounts to € 1646,00 ,according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer
10. **Evaluation and selection process:** Candidates will be assessed by the quality of their CV (40%); Grade of PhD degree and language proficiency in non-native languages (30%), and Motivation Letter (30%). The five best

classified candidates will be interviewed. Their final grade will be obtained by averaging CV, PhD degree, language proficiency and motivation letter (80%) with interview (20%).

11. **Selection Committee:** the composition of the jury: the President of the jury - Ana Simões; Panel Member 1 – Luís Miguel Carolino; Panel Member 2 – Maria Paula Diogo; Substitute Panel Member – Samuel Gessner
12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.
13. **Deadlines:** This call for applications is open from 02/02/22 to 28/02/2022 .
14. **Application:** Applications should be sent via e-mail to ciuhctcomunica@fc.ul.pt, by attaching the following documents:
 - a. Curriculum vitae - **CV may be provided in PDF or through the CIÊNCIAVITAE system;**
 - b. Certificate of completion of previous degree;
 - c. Proof of language proficiency in non-native languages;
 - d. Motivation Letter
 - e. Up to 2 recommendation letters
15. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date

Note 1: The documents that prove the entitlement of the academic qualifications and diplomas, or the proof of registration in the academic degree or diploma requested on the call, can be dismissed during the application period and replaced by a declaration on their honour from the applicant. Their delivery is mandatory for the fellowship contractualization.

Note 2: Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
